## 2009 Terms of Use

NORTHERN LIGHTS CAMP is a private camp, owned and operated by the Dakota Conference of Seventh-day Adventists. The primary purpose is to serve the needs, both recreational and spiritual of those who are members of the Seventh-day Adventist churches in the Dakotas, their families and friends.

**I. THE CAMP MAY BE USED FOR:**

- a. Family activities
- b. Church-sponsored groups
- c. Conference-sponsored activities

**II. HOW TO MAKE ARRANGEMENTS:**

All arrangements for use of NORTHERN LIGHTS CAMP must be made through:

**III. FEES:** Though the camp belongs to the church members of the Dakota Conference and was made possible by their efforts and sacrifices, fees are necessary for the maintenance and other costs in operating a camping program.

A \$25.00 application fee (non-refundable) is due with the application and will be deducted from the total cost.

**GENERAL REGULATIONS:**

1. Persons who use the camp must register with the one in charge when they arrive and sign check out when they leave.
2. Neither the Dakota Conference nor its staff, nor its volunteers, nor the Northern Lights Camp Committee will be responsible for losses or accidents which may occur on camp property.
3. Anyone using the camp will be responsible for damages other than normal wear and tear. Campers are expected to keep the grounds, cabins, restrooms, cafeteria, and lodge clean and orderly at all times.
4. Campfires are allowed only in designated areas. Camp stoves may be used. All fire building must heed to all fire danger indexes.
5. Use of the cafeteria requires all dishes and equipment be washed and left clean.
6. The use of any unclean meats (such as pork, lobster, etc.) is prohibited anywhere on the premises.
7. Use of alcoholic beverages, drugs and tobacco is prohibited anywhere on the premises.
8. The camp will remain beautiful only as long as its natural beauty is preserved. Therefore trees are not to be cut by visitors. Carving or defacing the trees is strictly forbidden. Herbaceous plants are not to be taken from the camp.
9. Use of four-wheelers, ATVs, or any other motorized vehicles on trails is not permitted except for maintenance purposes.
10. In order that campers may enjoy the wildlife in the area, it is requested that no pets be brought into camp.
11. It is requested that no shoes be worn on the carpet in the lodge.
12. Please leave all facilities cleaner than you found them. Sweep all floors, vacuum all carpeted areas and clean all bathrooms thoroughly. Please follow the cleaning instruction sheets posted in each building.
